ARRIVAL, DRESS REQUIREMENTS AND MOBILE PHONES

a)	ALL players are required to TO ARRIVE AT LEAST 30 MINUTES prior the start time. <u>ON ARRIVAL THEY MUST FIRST REPORT IN - and pay their match fee - TO THE MATCH OFFICIAL - PRIOR TO GETTING CHANGED.</u> This must, at the latest - be 15 minutes before the scheduled start time.
b)	Jumpers, Fleecees/Zipppers/Hats/Caps MUST BE White or <u>approved County merchandise.</u> If you are unable to comply with the dress code, contact the County Secretary - in advance of the match date.
c)	All players must use blue County Stickers on their woods - unless advised otherwise by the Team Manager.
d)	Under no circumstances are Mobile phones be used on or around the green during a match. Any player who smokes - including e-cigarettes - MUST use areas designated by the host club.
