INFORMATION FOR PLAYERS SELECTED FOR ALL - COUNTY MATCHES

ALL - PLAYERS - MUST READ AND ABIDE BY THE FOLLOWING NOTES. FAILURE TO DO SO, MAY RESULT IN A PLAYER NO LONGER BEING CONSIDERED FOR SELECTION.

ACTIONS PRIOR THE MATCH DAY

- a) **ALL PLAYERS** - should make a note of the Contact number for the Match Official, for use if a problem on the day. Any problems - or expected later arrival - **MUST BE** phoned to one of the two contact numbers on the team sheet.

ARRIVAL, DRESS REQUIREMENTS AND MOBILE PHONES

- a) **ALL** players are required **TO ARRIVE AT LEAST 30 MINUTES** prior to the start time and **ON ARRIVAL THEY MUST IMMEDIATELY REPORT IN** - and pay their match fee - **TO THE MATCH OFFICIAL.**

As the Men's and Women's shirts/blouses are of a different style - THEY ARE NOT ACCEPTABLE TO BOWLS ENGLAND TO BE WORN IN THESE MATCHES.

- (i) **For this specific match the dress is Men's shirt and plain White, Shorts, or Trousers or Culottes below the waist, with white socks and flat soled bowling shoes.**
- b) Jumpers, Fleecees/Zipper/Hats/**Caps** **MUST BE** White or approved County merchandise.
- c) All players must use blue County Stickers on their woods - unless advised otherwise by the Match Official.
- d) Under **NO CIRCUMSTANCES** are Mobile phones to be used on or around the green during a match. Any player who smokes - including e-cigarettes - **MUST** use areas designated by the host club.

POST MATCH

- a) ~~Players ARE EXPECTED to remain for the after Match snacks (even when games are cancelled after arrival). Any player who - in exceptional circumstances only - is unable to remain for the after match meal, MUST notify reasons to the Match Official as early as possible but will still pay the full match fee.—~~
- c) **Score Cards are to be handed to the Umpire - on completing of the match - and prior to taking any other actions.**
